#### From the President

2016 has been an exciting time for UPAWS! Since UPAWS inception over 40 years ago, we've become a leader in the no-kill movement helping save the lives of more animals than we ever thought possible. While there truly is "no



place like home," our current facility is simply beyond repair. Animal intake and services at UPAWS have grown dramatically over the years, but not the shelter space. Despite our run down, tired facility we accomplished a 98.6% save rate, finding homes for 1,081 animals through the support of our community, volunteers, donors, and staff in 2016. We've also been able to make our dream of a new home a reality by kicking off the public phase of our campaign for a new shelter.

By valuing our mission, our community has shown that not only will they support us in maintaining a safe haven while finding lifelong homes for the animals in our care; but have responded with astounding support of shared aspirations of a new facility that can expand our life saving services for years to come. We are grateful to our hardworking staff who does the unending work of sheltering pets daily while increasing kennel enrichment; our Board of Directors who have put in countless hours of research to help set direction of our organization's future and guidance for expanding services to help fulfill our mission; to our volunteers who have embraced our expanding Foster, Adoption Ambassador, Fundraising, Transport, and Daily Operation Programs.

#### **News From the Shelter**

Shelters helping Shelters- Over the years we have been networking with other shelters to increase lifesaving efforts state-wide and nation-wide. By partnering with other shelters and transferring in new animals for adoption, we are able to give pets a new audience to help them find their forever homes. In 2015 we transferred 154 animals into our shelter and in 2016 we nearly doubled that number by transferring in 309 animals for adoption! We are very selective when we accept new animals to transfer and only accept new animals from other shelters & rescues when we have space and resources to humanely house them prior to adoption. Together, with



these other shelters, we are networking to get pets adopted and moved out of high-kill shelters.

Pets for Patriots: The companionship of an animal can be life changing and comforting for a veteran. As a way to share our appreciation for their service, veterans are now able to adopt adult companion animals as pets for no charge!



Adoption Ambassadors: In 2016, select foster homes stepped up their game by becoming adoption ambassadors. What is an adoption ambassador, you ask? They are foster homes that are empowered and trained to take control of the adoption of their foster pets right from their home. They are trained to conduct adoption counseling, organizing meet and greets from their homes, and can finalize adoptions right from their living rooms. How cool is that!?

Extra Special Pets for Extra Special People: Thanks to the generosity of Lil' Bubs Big Fund for the ASPCA and Maddies Fund, we have been able to develop a new program that offers post-adoption support for animals with manageable or treatable illnesses or manageable behavioral issues. With grant funding offered from these two organizations, we are now able to cover the costs of medications, prescription diets, follow up veterinary exams, and behavioral training with a certified dog trainer for selected pets who need a little extra help getting adjusted to their new homes.

#### Making their stay more comfortable and fun through enrichment:

A part of our mission is to create a safe haven for the homeless animals of our community. To increase the comfort and enjoyment of the pets in our care we have continued to develop our enrichment programs for all critters. Dog enrichment includes 4 walks a day, playgroups for dog-friendly pups, mental games with puzzle toys, and scent enrichment with flavorful sprays on bedding and soft toys to get their sniffers going and keeping their minds busy while in their kennels. Thanks to Maddies Fund we were also able to develop a strong cat enrichment program. With the Maddies Fund innovation grant we were able to purchase fitted cage covers for shy and scared cats, catnip, Feliway calming sprays, plug ins, and calming collars. We also have incorporated supervised and leashed outdoor adventures for the bravest kit-



ties. You may also see some green on our windowsills, as we've begun to grow our own organic cat grass and catnip right in the shelter.

#### Increased promotion of pets on Social media:

Petfinder and Orvis joined efforts to provide grant funding that allowed us to increase the promotion of dogs for adoption with Facebook ads. Our promotion program has been sustained by donors so promotion of sponsored ads on Facebook continues to make an impact for our UPAWS pets.

#### Helping lost pets get home faster:

Thanks to grant funding from the Binky Foundation, we were able to purchase pet microchip scanners and disperse them to the local law enforcement agencies that did not already have a scanner. Forsyth Township, Negaunee City, Ishpeming City, Ishpeming Township, Marquette County Sheriff, and the Negaunee Michigan State Police Post now all have the ability to scan stray pets for microchips to connect them back home faster.

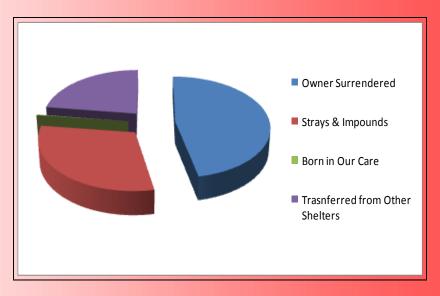

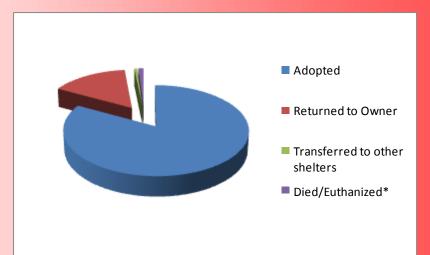

#### **Capital Campaign Update**

At the new UPAWS facility, which is replacing our 40 year old one, we will be able to continue the excellent care we provide homeless animals, but we will be able to do so much more. We will have on-site educational sessions for kids, to teach them about animal empathy, humane education, and how animal shelters are run. We will create a 'Read to Your Shelter Pet' program to help children with their literacy skills, while engaging animals safely. We will have dog training and cat socialization in a calm and comforting environment that sets the animals up for success. We will have a 2 acre off-leash, year-round, community dog park. We are confident that this new shelter, and the programs that we can offer, will be a source of pride for Marquette County.

#### Highlights for 2016:

- Hired a local firm to become our contract manager to reduce the cost of construction by 40% from original estimate
- Established a \$3.7M fundraising goal to fund construction and equipment for the building
- Surveyed the 20 acre parcel of property UPAWS purchased
- Obtained multiple grants for the new shelter including: Petco Foundation, Ray & Peg Hirvonen Foundation, and the Windfall Foundation.
- Established giving opportunities for local businesses
- Created partnerships with local media to tell our story
- Through lead gifts and the quiet phase, we raised 50% (\$1.8M) to launch the public phase of the capital campaign (October)
- Announced a 10 week & \$100,000 community challenge to receive \$100,000 from the Troudt Fund of the Community Foundation of Marquette County
- Reached \$100,000 2 days before the deadline, triggering a second challenge to raise \$10,000 in 48 hours to receive ANOTHER \$10,000 from the Troudt Fund
- In total during the challenge, raised \$119,411 from over 250 members of our community. Received full matching gift of \$110,000.
