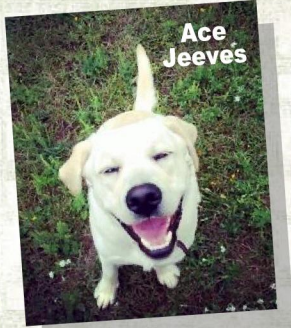

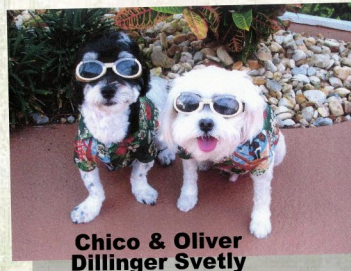

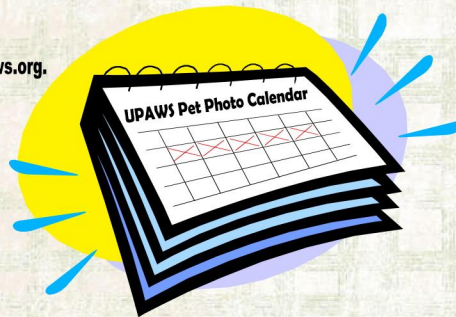


## 2016 Pet Photo Calendar Contest
