- 1) Call to Order/Attendance: Meeting called to order at 6.02 pm
- 2) Public Comment: None

3) Approval of Agenda:

- a) Add 6d "Verbal Offer on Snowfield property".
- b) Move 7a to the end of New Business; renumber New Business appropriately.
- c) Delete 7d "Review 3 quotes for Building Insurance"; Auto Owners Insurance is no longer insuring animal shelters therefore delete discussion from Agenda.

Motion made by Joan, seconded by Bob, to accept the December Board Agenda as amended. Motion passed with unanimous consent.

4) <u>Mission Moment:</u> Mission Moment shared by Kathy. She verbally touched on qualities of individual Board members and how they each contribute to the UPAWS Board and mission. Discussion of future Mission Moments. Board decided that if any future plans/ideas to be discussed, time on the agenda will be set aside by request.

(Jim Kinnunen joined the meeting at 6:08 pm)

5) Approval of Minutes:

- a) November 26, 2018 Regular Board Meeting Minutes. Changes verbally reviewed from 1st draft posted to Google drive on page 4, 14(c) and 15. Motion made by Joan, seconded by Bob, to approve the November 26th Meeting Minutes as noted. Motion passed with unanimous consent.
- b) Closed Session Meeting minutes from November 26, 2018. Motion made by Joan, seconded by Scott, to approve minutes as submitted. Motion passed with unanimous consent.

6) <u>Unfinished Business:</u>

- a) New Shelter Construction Update: Joan reported that cleaning of the facility has started; punch list items are being completed; HVAC system balancing began today; second 1,000 gallon propane tank was delivered today; no official completion date has been set; facility not yet secure in order to bring sensitive items such as computers, etc. January Board meeting can be held on site and scheduled move date is the week of January 2nd for shelter animals. Spring 2019; horse barn foundation/floor to be poured; dog park fencing installed; and play yard areas dog park areas to be seeded. Noted that full mortgage amount will be utilized.
- b) <u>Transition Plan for Move to New Shelter</u>: everything on same schedule; storage shed items have been moved to the new shelter; Michigan Pet Fund Alliance training to be scheduled while shelter is closed for transition; Bob offered assistance with moving over the holidays; Kathy to coordinate with Ryan to get updated information to the Board.
- c) <u>Update on 2019 Operational Budget</u>: Kathy, Joan and Reva met to work on the 2019 budget; budget is still not balanced due to a deficit of approximately \$85,000; Petco funds used to decrease the deficit. 2019 Budget approval will be a January Board action item.
- d) <u>Verbal Offer on Snowfield Property</u>: Kathy reported that Terry Bengry (?) has offered to buy Parcel A (4.55 acres) for \$7,000. He is willing to take down the building and agree to deed restrictions. Board will need to get the County to agree to transfer. Road Commission stated that they were taking back Parcel B. County wants \$2,000 per acre.

 Motion made by Amber, seconded by Scott, to accept offer from Terry and to continue conversation with County to request that they accept the lesser value. Discussion: request that closing costs be covered by Terry and that he agree to deed restrictions. Final offer will be brought back to the full Board for further action. Motion passed with unanimous consent.

7) New Business:

- a) Recommendation from Finance Committee Donation Allocation: Finance Committee recommended that the donation received on 12/10/2018 in the amount of \$62,500 be allocated to the operating reserve/savings account. Motion made by Reva, seconded by Bob. Motion passed with unanimous consent.
- b) Recommendation from Policy & Bylaws Committee Final Draft of Board Policies and Procedures:

 Policy / Bylaw Committee recommended the adoption of the UPAWS Board of Directors Policies and Procedures. Motion made by Christian, seconded by Joan. Motion passed with unanimous consent.
- c) <u>Timeline for UPAWS Strategic Plan:</u> Karen is waiting for the \$5,000 budgeted to be available before moving forward. Joan suggested that the process begin in February so that the Board can complete the plan by December. Motion made by Colleen, seconded by Joan, to ask Karen to come to the January meeting with a timeline for 2019 work. Motion passed with unanimous consent.
- d) January Board Meeting Location: January Board meeting to be held at the New Shelter on

- January 28th at 6:00 pm.
- e) <u>Board Work Session plan and schedule for next one</u>: Board still needs to work on 2019 budget and Legacy Committee discussion. Board Work Session scheduled for Monday, January 14th at 6:00 pm to be held at the new shelter.
- f) Recommendation from Board Development New Board Member: Board Development Committee recommended Alex Petrin to fill a vacant Board position with a term expiring in 2019. After secret ballot was held, Alex was unanimously approved with 9 "Yes" votes as a new UPAWS Board member.

Other Animal-Related Happenings:

- The transition to the new shelter has gone fairly well. Although there have been some minor challenges, overall, I feel that we are right where we need to be. Cleaning routines have adapted. Organization has improved. And we have developed new processes for the new shelter. Some items still need to be unpacked, but these are slowly being addressed. Our next challenge will be opening the new shelter to the public, which will bring about new tasks, but I feel that we have a good foundation with the right personnel in place.
- We are overhauling the color code system for our animals. From now on the colors will be green, yellow, and red. Green will represent animals that have no restrictions and can be handled by entry level staff or volunteers. Yellow will represent animals that can be handled by those with intermediate experience levels. These animals can also be handled by volunteers and staff. Red will represent those animals that require staff members for interaction.
- -The pricing structure for adoption rates has been changed. Some small increases have occurred, while other categories remain the same, such as senior rates. A new category has been introduced for juvenile/juniors that will apply to animals 6 months old and going up to 1 year old. The website will be updated with the new pricing.
- The ability to send Austin the dog to a boarding/ training facility has fallen through. The business was sold and the former owner did not recommend continuing his training through her old business. My next course of action is to contact Best Friends in an attempt find a sanctuary for Austin.

Maintenance

- The old shelter has been 95 percent emptied. What remains are small amounts of equipment that will slowly come over to the new shelter once we complete our unpacking. The water from

the hot water heater has been drained and the pipes emptied as much as possible. The power to the point pump has been shut off. Until further outcomes, the temperature has been turned down to 50 degrees.

- Alex Petrin has designed and constructed numerous shelving units for the new shelter. These shelves will be utilized in the laundry room, food prep, and the garage.
