- 2. <u>Approval of Agenda</u>: Colleen made a motion, seconded by Chris, to approve the Agenda as presented. Motion passed with unanimous consent.
- 3. New Business:
 - a. Resignation of E.D. Public perception regarding Beverly's resignation after such a short period of employment was discussed. It was the board's consensus that due to confidentiality issues, past practice has been to respond only with reasons cited in the employee's resignation letter, which in this case for were personal reasons. Reva also noted that Bev (via email) has offered to act as a consultant on several projects on a short-term basis. Request was denied; Reva will advise Bev.
 - b. <u>Advance Payback Plan</u> Discussion of \$5,000 advance given to Bev to facilitate her move for the position. *Motion was made by Colleen, seconded by Austin, to implement the following plan:*
 - UPAWS will withhold \$400 from first paycheck (for pay period 12/15-12/28)
 - UPAWS will withhold the entire amount of second paycheck (for pay period 12/29-1/11)
 - Balance of monies due to be repaid monthly (\$400 per month via bank transfer) beginning in February until all monies are paid off.

Motion passed with unanimous consent.

- It was also noted that we need an agreement stating the above signed by Bev, any documents needed to facilitate the bank transfer, plus a completed I-9 form.
 Personnel Committee will draft the payment plan.

Suggested Changes are noted in **RED**.

Current UPAWS Bylaws Policy Language:

- E. Resignation and Removal of Board Members:
 - a. Any Board members may resign at any time by giving written notice to the President of the Board, and such resignation shall be effective on the date specified in the notice. If by reason of resignation or removal the number of Board members is less than a quorum necessary to manage the Board of Directors, the Board shall take such action as may be necessary to establish a quorum, including naming interim Board members.
 - b. If removal of any Board member is based upon any publicly made accusation of misconduct or wrongdoing on the part of the Board member, s/he shall be given an opportunity to answer to any such accusation before the Board at a meeting held for that purpose. The decision to remove or not to remove any Board member with cause shall be determined at such regular or special meeting of the Board of Directors by the affirmative vote of two-thirds (2/3) of the Directors then in office.
 - c. Any Board member who is absent from three consecutive UPAWS Board meetings without notification to the Board President, shall be removed as a member of the UPAWS Board of Directors.
 - d. Any Officer may be removed with cause by the affirmative vote of two-thirds (2/3) of the Directors then in office at any regular or special meeting of the Board of Directors.

Report & Recommendation: Requested Feedback on Changes to UPAWS Bylaws re: Suspension of Bylaws.

Request for Feedback #1:

At the June 2019 UPAWS Board meeting, a request was made to research whether the practice of suspending the Bylaws as a practice should or could be employed from time to time.

The Policy & Bylaws Committee makes the following recommendation for language changes to Article 12: amendments in regards to temporary suspension to the Bylaws.

Suggested Changes are noted in RED.

Current UPAWS Bylaws Policy Language:

Per Article 12: Amendments:

"These Bylaws may be amended, altered, restated, changed, added to repealed or temporarily suspended at any regular or special meeting by the affirmative vote of not less than two-thirds vote of the entire Board, provided written notice of the proposed amendment was provided to all Board members at least ten (10) calendar days prior to the meeting. The Bylaws, as amended, will receive final approval by the Board of Directors."

Report & Recommendation:

The Policy & Bylaws Committee makes the following recommendation for language changes to Board Policy 5.0 Board of Director's Responsibility as the Governing Body.

Add on Page 14: create new (I).

Suggested Changes are noted in **RED**.

I. Chain of Command: When a concern, complaint or issue, which needs to be resolved, is brought to the Board or an individual Board Member's attention by a community member, Board members shall direct the community member to the Executive Director for addressing concerns, complaints or related issues.

Request for Feedback #2:

At the June 2019 UPAWS Board meeting, a request was made to research whether the policy on UPAWS Memberships could be waived for individuals based upon cumulative past donations versus one time or annual donations.

Per Board Policy 1.0 About the Shelter

UPAWS Membership

A. Membership Dues: The following schedule sets forth the dues:

a. Annual \$20.00/person/yearb. Lifetime \$500.00/person/one time

c. Business

i. Supporter \$100-\$199/yearii. Sponsor \$200-\$499/yeariii. Patron \$500-\$999/yeariv. Benefactor \$1,000 and above/year

- B. Annual Membership Dues: Annual membership dues must be paid every twelve months to remain in good standing. All memberships expire on the final day of the month in which the qualifying donation was made in the previous year.
- C. Granting Lifetime Memberships: The Board of Directors, at its discretion, may grant annual or lifetime memberships. Assisi Award winners shall be granted automatic individual lifetime memberships.

The Policy/Bylaw Committee Recommendation is that the Board Policy 1.0 About the Shelter, UPAWS Membership, as written, should remain as-is. No changes are recommended at this time.
