OF THE ANIMALS AT THE SHELTER DURING THE YEAR, 1,194 WERE ADOPTED, 277 WERE RETURNED TO THEIR OWNERS, 33 WERE TRANSFERRED OUT AND 44 DIED OR WERE EUTHANIZED. THE ONLY ANIMALS EUTHANIZED HAD A SEVERE ILLNESS/INJURY OR AGGRESSIVE AND DANGEROUS BEHAVIOR. NOT ONE SINGLE ANIMAL WAS EUTHANIZED FOR SPACE OR HAD A TREATABLE MEDICAL CONDITION.
